Phishing, ransomware, malware... The number of cyberattacks continues to rise; in 2020, 180,000 incident tickets were opened with the CIRCL (Computer Incident Response Center Luxembourg), compared with 100,000 in 2019 and 15,000 in 2018.

These figures underline the importance of strengthening our data protection, as well as the usefulness of dedicating an entire month to cybersecurity awareness.
